Purpose of processing personal data

Protection of privacy

This data may be processed by Finnish Plastics Industries Federation (FIPIF) as part of its customer administration procedures, market studies, or personalised information and promotional campaigns relating to its products and services.

In accordance with the GDPR, you have the right to view your personal data and, where applicable, have it corrected. You are also entitled to object, free of charge, to your data being used for direct marketing purposes. The legal basis for the processing of personal data

The primary reason for handling the personal data of the Finnish Plastics Industries Federation's web site is the customer relationship between the customer and the Finnish Plastics Industries Federation, the customer's assignment or any other relevant relationship. The data handling is thus based on either an agreement or a legitimate interest.

Data content of the website

The Finnish Plastics Industries Federation is responsible for the content of the sites. This content is provided "as it is" and "as available". We endeavour to update the information on a regular basis, but information is not claimed to be exhaustive, complete, timely and/or accurate.

Data content of the register

The organizer of each event or training is responsible for the personal data collected. The site and the registers deal with following information: enrolment for training, events and events, feedback, etc. The data content to be collected varies and is always the marked on the forms to be filled by the customer. The information provided by the person is handled by those employees of the Finnish Plastics Industries Federation whose activities or subject matter the form is intended for.

Regular sources of information

Regular delivery of information and retention time

The personal data (name, contact details) provided through the site will be forwarded for invoicing or for certification and registration. Our service providers comply with data protection legislation. Unless otherwise stated in the legal requirements, the information will be deleted from the register at the request of the customer.

The principles of protection
